



Limited Labor Warranty

Advanced Exteriors agrees to service the manufacturer's warranty at no charge to the buyer for 5 years. Advanced Exteriors warrants its workmanship of the work for 5 years after the date of substantial completion and will remedy substantial defects without charge to the buyer, in written notice from buyer within such period.

Advanced Exteriors and buyer agree that all implied warranties including, without limitations, warranties of habitability, fitness for a particular purpose and merchant ability are hereby excluded and there are no warranties or representations which extend beyond those expressly set forth in this agreement.

Repairs will be at buyer's expense when the cause of damage is structural defect, settling, acts of providence, or buyer's negligence resulting from structural settling, structural movement, structural defects, acts of providence, efflorescence, external physical causes of any kind, alterations to the coated surfaces, lack of proper drainage (standing water), preexisting conditions, substrate failure, buyer's negligence, leaks occurring around window frames, door openings, or leaks in or through roofs, and any such damage shall be repaired at Buyer's expense. Rhino Shield Ceramic Coating is not warranted on mechanical or moving parts. No other material installed or applied in conjunction with Rhino Shield Ceramic Coating material is warranted.

This warranty is transferable by the current buyer to subsequent owners, provided however that Advanced Exteriors receives written notice of the transfer within 30 days of the date of title transfer. Failure to do so will relieve Advanced Exteriors of any further obligation under this warranty.

Under no circumstances shall Advanced Exteriors' liability extend beyond repair or replacement of the products installed. Advanced Exteriors shall not be liable for, in any respect, any free-standing or retaining walls, any moving surfaces, gutters, any consequential damage resulting there from alterations to the coated surfaces, natural disasters, acts of God, lack of proper drainage (standing water), pre-existing conditions, substrate failure, leaks occurring around window frames, door openings, or through roofs not warranted by Advanced Exteriors.

Payment in full of the contract amount shall constitute the buyer's and Advanced Exteriors' acceptance of the terms of this warranty.

25 Year Non-Prorated Transferable Limited Warranty

The material making up the Rhino Shield Ceramic Coating System (Material) is warranted for twenty-five (25) years against chipping, flaking, or peeling.

The Manufacturer of the Material warrants that at any time up to twenty-five (25) years after the date of application, it will furnish, without shipping cost to the customer (shipped to the installer of the product or, at the option of Manufacturer, directly to the site where the product was applied), sufficient Material to remedy defective areas that result from inherent defects in the Material. Manufacturer assumes no liability for any service labor costs including application of coating or removal of prior coatings. This warranty is conditioned upon proper application and installation of the Material, for which the Manufacturer of the Material is not responsible or liable and which the Manufacturer did not perform.

Upon written notice from buyer during the warranty period and provided that the Warranty is properly registered, and the claim is valid, Advanced Exteriors Inc warrants that it will provide new Material to remedy defects in the Material for a period of 25 years after the date of application. During the first 36 months after the completion date, Advanced Exteriors Inc warrants any service labor will be provided at no cost to the buyer.

Neither the Manufacturer nor Advanced Exteriors Inc warrants against damage resulting from structural settling, such as tears or cracks in caulking, failure of a previous paint, structural movement, improper installation or deterioration of other building components or cladding, structural defects, acts of God (including natural disasters such as hurricanes), efflorescence, external physical causes of any kind, alterations to the coated surfaces, lack of proper drainage (standing water), pre-existing conditions such as rust or water intrusion, improper maintenance, materials found to be defective by court order, substrate failure, buyer's negligence, leaks occurring around window frames, door openings, or leaks in through roofs, and any such damage shall be repaired at buyer's negligence, leaks occurring around window frames, door openings or leaks in or through roofs, and any such damage shall be repaired at buyer's expense. Rhino Shield Ceramic Coating is not warranted on mechanical or moving parts. Rhino Shield is not warranted to protect against or prevent wood rot, water intrusion, or other future component, classing, or substrate failure. No other products installed or applied in conjunction with the Material is warranted. A copy of this warranty and buyer's contract must accompany any warranty claim. THIS WARRANTY IS THE MANUFACTURER'S SOLE WARRANTY OF RHINO SHIELD CERAMIC COATING.

Rhino Shield is tested and formulated as an exterior wall coating. Therefore, the following application areas are excluded from this Warranty: shutters, gutters, pergolas, fences, windowsills, walking surfaces, railings, or other horizontal surfaces.

Normal weathering combined with the aging process will cause any colored surface to fade, darken, or acquire a surface accumulation of dirt or stains. For this reason, neither the Manufacturer or Advanced Exteriors Inc warrants against these changes in color.

This Warranty is valid only when initial installation is applied by the Manufacturer's approved applicators and in strict and full conformity with the Manufacturer's approved methods. Buyer is required to perform annual cleaning of their Rhino Shield coating Material.

This Warranty is transferable by the original buyer to subsequent Home-Owners, provided that Advanced Exteriors Inc receives written notice of transfer within 30 days after date of title transfer. Failure to provide proper written notice will relieve the Manufacturer and Advanced Exteriors Inc of any further obligation under this Warranty.

Under no circumstances shall the liability of the Manufacturer or Advanced Exteriors Inc extend beyond the furnishing of a replacement quantity of the Material. No other warranties exist, expressed or implied. The provisions of Warranty are in addition to any statutory warranty or other rights and remedies available under state and federal law. Payment in full of the contract amount shall constitute buyer's, Manufacturer's, and Advanced Exteriors Inc acceptance of the terms of this Warranty.
